**RESOLUTION AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS  
BETWEEN FORSYTH COUNTY, ON BEHALF OF THE DEPARTMENT OF  
SOCIAL SERVICES (FCDSS), AND CARDINAL INNOVATIONS  
HEALTHCARE ALLOWING FCDSS TO BECOME A CARDINAL  
INNOVATIONS HEALTHCARE NETWORK PROVIDER AND TO BILL  
FOR ELIGIBLE MEDICAID SERVICES PROVIDED BY THE  
FCDSS CLINICAL SOCIAL WORK UNIT  
(DEPARTMENT OF SOCIAL SERVICES)**

**WHEREAS**, the Forsyth County Department of Social Services has one of the few Licensed Clinical Social Work Units in the State of North Carolina which employs clinicians who have been certified in Trauma Focused Cognitive Behavioral Therapy by UNC Chapel Hill and Duke University's Child Treatment Program; and

**WHEREAS**, the Clinical Unit provided 1,825 individual therapy sessions during 2017 to meet the clinical needs of children who have experienced trauma by way of abuse, neglect, and/or dependency; and

**WHEREAS**, 80% of these services are eligible for Medicaid reimbursement; and

**WHEREAS**, the Forsyth County Department of Social Services desires to re-execute a 2016 agreement to become a part of the Cardinal Innovations Healthcare provider network; and

**WHEREAS**, as a network provider, the Licensed Clinical Social Workers will be able to bill Medicaid for eligible activities resulting in 75% reimbursement to the County.

**NOW THEREFORE BE IT RESOLVED** that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County and the Department of Social Services, necessary documents authorizing the Department of Social Services to become a Cardinal Innovations Healthcare Network Provider and to bill Medicaid for eligible clinical services provided by the Licensed Clinical Social Work Unit, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the Forsyth County Attorney.
