

**RESOLUTION APPROVING THE AMOUNT TO BE SPENT BY THE
WINSTON-SALEM/FORSYTH COUNTY BOARD OF EDUCATION TO
ACQUIRE REAL PROPERTY TO BE USED FOR FUTURE IMPROVEMENTS
AT THE LEWISVILLE MIDDLE SCHOOL SITE
(PIN # 5886-75-2443, 5886-75-3443, 5886-75-4443)**

WHEREAS the provisions of N.C.G.S. 115C-426(f) require the approval by the Board of County Commissioners as to the amount to be spent by the Board of Education for school sites prior to the execution of a contract by the Board of Education for the purchase of a site or the expenditure of funds therefor;

WHEREAS on May 14, 2019, the Winston-Salem/Forsyth County Board of Education adopted a Resolution to exercise an Option to Purchase Real Estate relating to real property owned by Judy Anne Yates Tuttle, Richard E. and Lori C. Yates, and Jane B. Murray, to be used for future improvements at the Lewisville Middle School site, which property is PIN# 5886-75-2443, 5886-75-3443, 5886-75-4443, on the Forsyth County Registry, subject to approval of the proposed purchase amount by the Forsyth County Board of Commissioners as required by law; and

WHEREAS the Winston-Salem/Forsyth County Board of Education requests that the Forsyth County Board of Commissioners approve \$301,600.00 as the amount to be spent to purchase the above-described real property;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby approves the total amount of \$301,600.00 to be spent by the Winston-Salem/Forsyth County Board of Education for the purchase of land owned by Judy Anne Yates Tuttle, Richard E. and Lori C. Yates, and Jane B. Murray, which land is a portion of that real property described as PIN# 5886-75-2443, 5886-75-3443, 5886-75-4443, on the Forsyth County Registry and to be used for future improvements at Lewisville Middle School site.

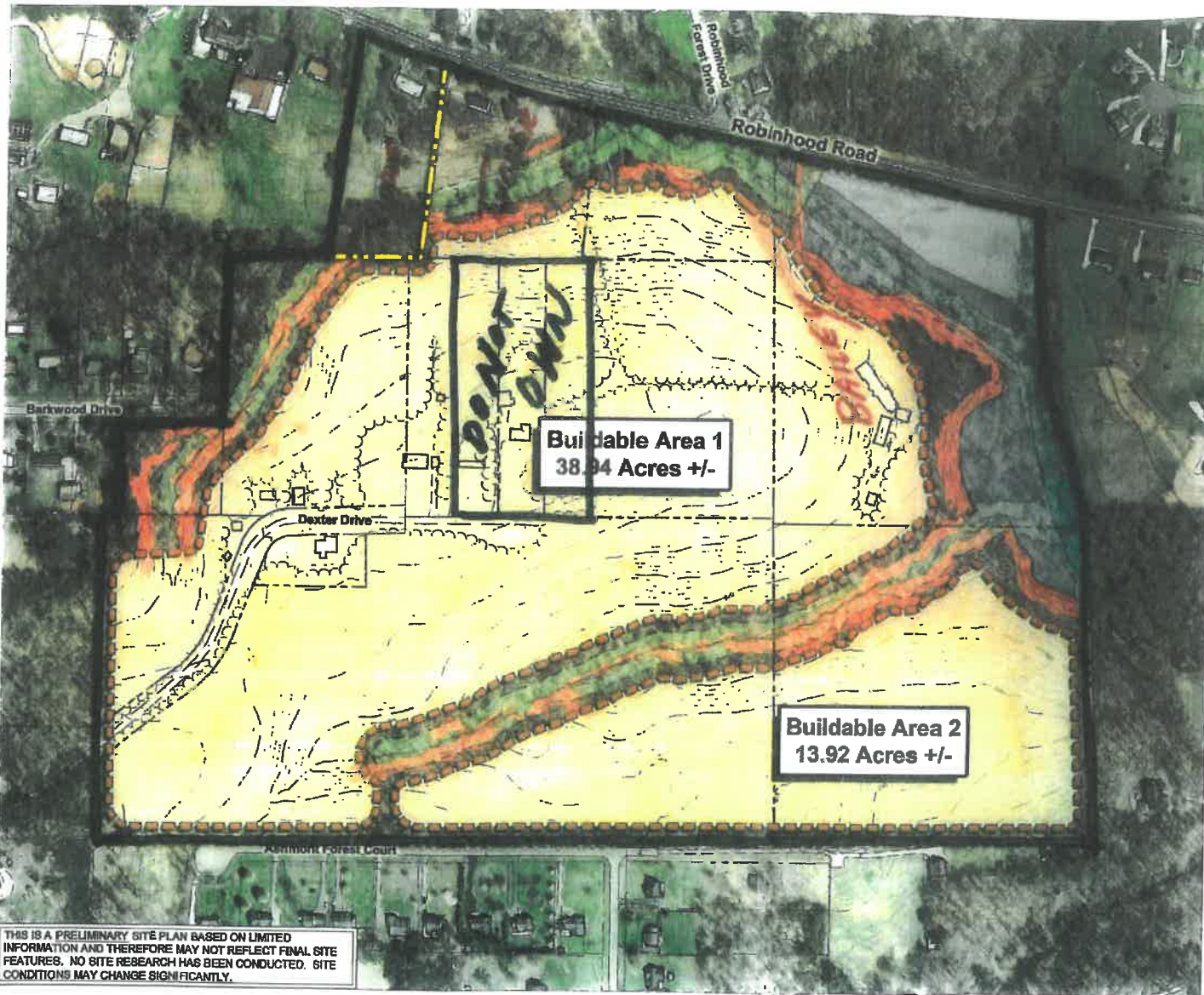
