COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:

SUMMARY OF INFORMATION:

A piece of public art would enhance the newly constructed Forsyth County Paddison Memorial Branch Library. In order to commission such public art a committee consisting of the City-County Public Art Commission, a Kernersville Town Council representative, a Kernersville Community Appearance Commission representative, and County staff reviewed 83 proposals and selected three finalists to interview. This committee recommends that the Forsyth County Board of Commissioners select artist Madeline Wiener to design, sculpt, and install public art at the Public Library's Paddison Memorial Branch in Kernersville for an amount not-to-exceed \$55,000.

**RESOLUTION AUTHORIZING EXECUTION OF AN AGREEMENT BETWEEN
FORSYTH COUNTY AND MADELINE WIENER FOR THE DESIGN, CREATION,
AND INSTALLATION OF AN OUTDOOR SCULPTURE FOR THE FORSYTH
COUNTY PUBLIC LIBRARY'S PADDISON MEMORIAL BRANCH**

WHEREAS a piece of public art would enhance the newly constructed Forsyth County Paddison Memorial Branch Library;

WHEREAS in order to commission such public art a committee consisting of the City-County Public Art Commission, a Kernersville Town Council representative, a Kernersville Community Appearance Commission representative, and County staff reviewed 83 proposals and selected three finalists to interview;

WHEREAS this committee recommends that the Forsyth County Board of Commissioners select artist Madeline Wiener for the design, fabrication, delivery, and installation of an original outdoor sculpture on or before June 30, 2020; and

WHEREAS the sculpture will be entitled, "Honeybee Curiosity" and will represent a young reader with two stacks of books; the main sculpture will be 4'x4'x3' and the book stacks will be 18"x36"x18", both sculpted from dolomitic limestone with an applied silicone sealer, sitting on concrete foundations;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County, an agreement with Madeline Wiener for the design, creation, and installation of an original outdoor sculpture for the Forsyth County Public Library's Paddison Memorial Branch Courtyard as described above at a cost not to exceed \$55,000, which includes travel expenses not to exceed \$1,750, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the Forsyth County Attorney.

AGREEMENT

THIS AGREEMENT, made and effective this 14th day of November, 2019, by and between Forsyth County, North Carolina (the "County"), and Madeline Wiener Sculptor, Inc. (the "Provider");

For the purpose and subject to the terms and conditions hereinafter set forth, the County and the Provider hereby agree as follows:

1. **Services.** Provider shall provide design development, engineering services, sculpting, delivery, and installation of a work of art at the Forsyth County Central Library Paddison Memorial Branch Courtyard in Kernersville, North Carolina

2. **Term.** The services of the Provider shall begin on November 15th, 2019 and unless sooner terminated by mutual consent or as hereinafter provided, shall be provided until September 30, 2020; provided that the County shall have the right to terminate this Agreement, without cause, upon 30 days' notice in writing to the other party, or upon 7 days written notice if the Provider breaches the Agreement.

3. **Compensation.** As full compensation for the Provider's services, the County agrees to pay the Provider the sum of \$55,000, payable in installments. The Provider shall bill the County in 3 Contractual Payment Milestones:

- a) Contractual Payment Milestone #1: 30% = \$16,500 (Est. Nov. 11, 2019)
Upfront payment to complete the following: Design work, create a mock up, identify site placement, complete engineering work, and order Dolomitic Limestone.
- b) Contractual Payment Milestone #2: 60% = \$33,000 (Est. Jan. 1, 2020)
Upon completion of all items under Milestone #1, upfront payment to complete the following: Acquisition of materials, production/fabrication, photos and videos of production and fabrication process.
- c) Contractual Payment Milestone #3: 10% = \$5,500 (Est. Sept 30, 2020)
Final payment received upon review and installation.

The County shall pay all such bills within the following 15 days provided all elements of the Agreement are satisfactorily met. Total payments under this contract are not to exceed \$55,000.

4. Independent Contractor. The Provider shall operate as an independent contractor, and the County shall not be responsible for any of the Provider's acts or omissions. The Provider, its employees, and subcontractors shall not be treated as an employee with respect to the services performed hereunder for federal or state tax, unemployment or workers' compensation purposes. Neither federal, state, nor payroll tax of any kind shall be withheld or paid by the County on behalf of the Provider or the employees of the Provider. The Provider is fully responsible for the payment of any and all taxes arising from the payment of monies under this Agreement. The Provider shall comply with the North Carolina Workers' Compensation Act and shall ensure that its subcontractors also comply. The Provider shall not be treated as an employee with respect to the services performed hereunder for purposes of eligibility for, or participation in, any employee pension, health, or other fringe benefit plan of the County. The Provider has no authority to enter into contracts or agreements on behalf of the County. The County shall not be liable to the Provider for any expenses paid or incurred by the Provider unless otherwise agreed in writing. The Provider shall supply, at its sole expense, all equipment, tools, materials, and/or supplies required to provide contracted services unless otherwise agreed in writing.

5. Indemnification. The Provider agrees to indemnify, defend, and hold the County harmless from and against any and all claims, expenses (including attorney fees), costs or liability for acts or omissions of the Provider relating to this Agreement or services provided pursuant to it.

6. Insurance. The Provider shall maintain, at its sole expense, insurance coverage as required by the Forsyth County Risk Manager.

7. County Property. Provider agrees that it shall be responsible for the proper custody and care of any property furnished to it by the County for use in connection with the performance of this contract and will reimburse the County for loss of, or damage to, such property. Any information, data, documents, studies, or reports given to or prepared or assembled by the Provider under this Agreement shall be kept confidential and not divulged or made available to any individual or organization without prior written approval of the County.

8. Notice. All notices permitted or required to be given by one party to the other party shall be addressed and delivered in writing as follows:

9. **Assignment.** The Provider may not assign its obligations under this Agreement unless it has received prior written approval from the County, which may be withheld at the sole discretion of the County.
10. **Waiver.** No action or failure to act by the County shall constitute a waiver of any of its rights or remedies or as approval or acquiescence in a breach thereunder, except as may be specifically agreed in writing.
11. **Governing Law.** This Agreement shall be governed by North Carolina law, except that provisions regarding conflicts of laws shall not apply. The venue for any legal proceeding shall be in Forsyth County, North Carolina.
12. **Nonappropriation.** Notwithstanding anything to the contrary herein, in the event that public funds are unavailable and not appropriated for the performance of the County's obligations under this Agreement, then this Agreement shall automatically expire without penalty to the County 30 days after written notice of the unavailability and non-appropriation of public funds. In the event of a change in the County's statutory authority, mandate, or mandated functions by state or federal legislative or regulatory actions, which adversely affects the County's authority or duty to continue its obligations under this Agreement, then this Agreement shall automatically terminate without penalty to the County 30 days after written notice of such limitation or change in the County's legal authority or duty.
13. **Survival of Provisions.** All obligations arising prior to termination of this Agreement and all provisions of this Agreement allocating responsibility or liability between the parties shall survive the completion of services and termination of this Agreement.
14. **Modification.** This Agreement may only be modified in writing and signed by both the Provider and by the County Manager or other authorized County official.
15. **Conflict with Attachments.** In the event of any conflict between the provisions in this Agreement and any provisions in an attachment thereto, the provisions in this Agreement shall take precedence over any provision in an Attachment.
16. **Miscellaneous.** The Provider shall comply with all applicable laws and regulations including but not limited to federal, state and local laws regarding business permits, certificates, and licenses that may be required to carry out the services to be performed under this Agreement and all federal immigration laws in its hiring and

contracting practices. Provider and its subcontractors shall comply with Article 2 of Chapter 64 of the North Carolina General Statutes relating to the required use of the federal E-Verify program to verify the work authorization of newly hired employees. Failure of the Provider to comply with this provision or failure of its subcontractors to comply could render this contract void under North Carolina law. Provider hereby certifies that it is not on the North Carolina State Treasurer's lists of persons engaging in business activities in Sudan (Darfur), Iran, or boycotting Israel, prepared pursuant to NCGS §§ 147-86.43, 147-86.58, and 147-86.81, nor will Provider utilize for this Agreement any subcontractor on such lists. This agreement is intended for the benefit of the County and the Provider and not for any other party. If any provision of this Agreement shall be unenforceable, the remainder of the Agreement shall be enforceable to the extent allowed by law.

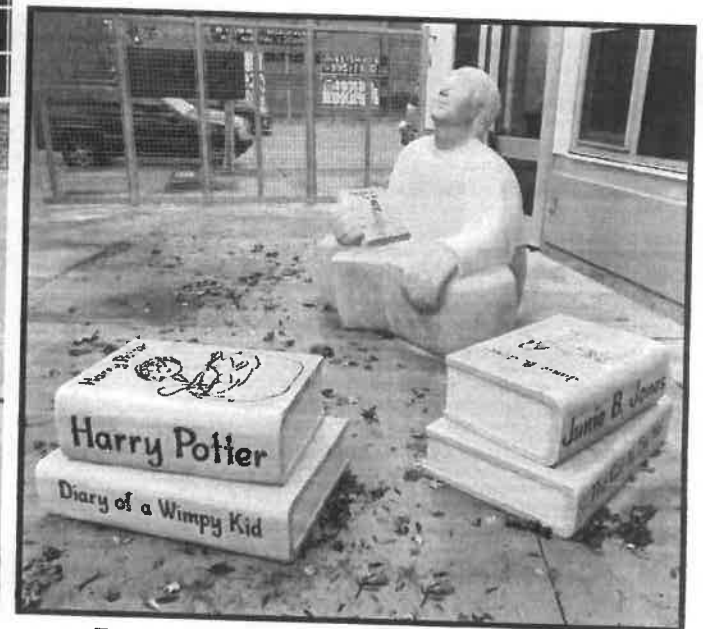
For this project, I've decided to create a little girl in my 'Bench People' style. She will be reading a book that is open to a page about honeybees. There will be a capital H on the upper right corner of the book with illustrations of honeybees and their honeycombs. Children will be able to sit on her lap and look at the book, and others will be able to sit on either of two short stacks of books which will be sandblasted with the title "Honeybees" (similar to my Kohl Children's Museum installation in Chicago where the open book is about the Tully Monster fossil and my Emeryville, CA installation). On the book benches, there will be illustrations of honeybees and flowers and a beehive pattern.

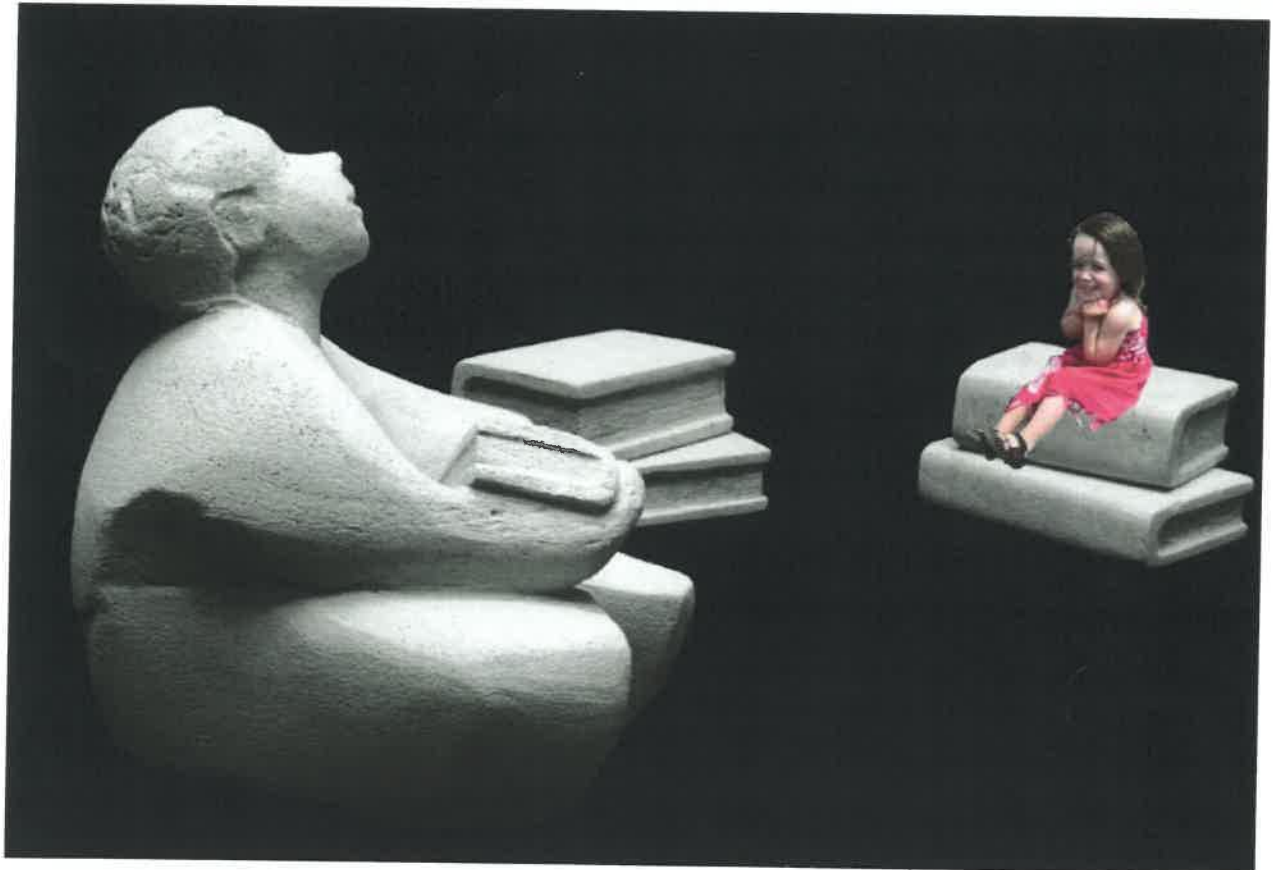
