SUMMARY OF INFORMATION:

The Preventive Health Services Division of the Forsyth County Department of Public Health received notification of an additional \$62,500 in grant funds from the North Carolina Department of Health and Human Services for the Care and Prevention in the United States (CAPUS) Safe Spaces Program. This program will deliver important HIV/AIDS information and services to targeted populations in our community.

The grant funds will be used to hire a part-time facilitator through a temporary agency to administer the program, including travel, training, and program supplies. The facilitator will work with the target populations through:
