Nonfood-contact surfaces of equipment and utensils shall be kept free of an accumulation of dust, dirt, food residue, and other debris.
- 55 6-501.12 Cleaning, Frequency and Restrictions-REPEAT-C: Thorough cleaning is needed to/on the following: floors throughout the prep area, walls throughout the preparation area, floors in the and inside floor drains. Physical facilities shall be cleaned as often as necessary to be maintained.
