**RESOLUTION AUTHORIZING EXECUTION OF A LEASE AMENDMENT  
BETWEEN FORSYTH COUNTY AND THE UNITED STATES OF AMERICA ON  
BEHALF OF ITS DEPARTMENT OF AGRICULTURE (USDA), RURAL  
DEVELOPMENT DIVISION, FOR LEASE OF COUNTY OWNED PROPERTY  
(FORSYTH COUNTY AGRICULTURAL BUILDING)**

**WHEREAS**, Forsyth County owns the Forsyth County Agricultural Building located at 1450 Fairchild Drive, Winston-Salem, N.C. in which it plans to lease 2,349 square feet of office space (Rooms 302, 3021, 304, 3041, and 3061) to the United States of America on behalf of its Department of Agriculture (USDA), Rural Development Division, for a two year term beginning August 1, 2017 and ending July 31, 2019, at an annual rental of \$19,943.01 payable in equal monthly installments of \$1,661.91; and

**WHEREAS**, the above-described property will not be needed by Forsyth County for County purposes during the term of the proposed amended lease; and

**WHEREAS**, pursuant to the provisions of N.C.G.S. 160A-272, notice has been timely given by publication describing the property to be leased or rented, stating the annual rental or lease payments, and announcing the Board of County Commissioners' intent to authorize the lease or rental at its next regular meeting;

**NOW, THEREFORE, BE IT RESOLVED** by the Forsyth County Board of Commissioners that the Chairman or County Manager and the Clerk to the Board are hereby authorized to execute the above-described Lease Amendment, on behalf of Forsyth County, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney. The original Lease Amendment is attached hereto and incorporated herein by reference.

**THIS AGREEMENT**, made and entered into this date by and between **Forsyth County** whose address is: **201 N. Chestnut Street, Forsyth County Gov. Center, 4<sup>th</sup> Floor, Winston-Salem, North Carolina 27101**

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

**WHEREAS**, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon execution by the Government as follows:

1. **This Lease Agreement is issued to extend the lease term beginning August 1, 2017 through July 31, 2019.**
2. **The Government will pay the lessor annual rent of \$19,943.01 payable at the rate of \$1,661.91 per month (representing \$8.49 per square feet for 2,349 usable square feet) in arrears. This extension reflects the mutual agreement of USDA releasing 464 square feet of unused office space.**
3. **Pursuant to the Lease Agreement, the tenant reserves the right to terminate this lease or decrease the amount of space at any time by giving at least 120 days notice in writing to the Lessor.**
4. **The Lessor must have an active/updated registration in the System for Award Management (SAM) [www.SAM.gov](http://www.SAM.gov), upon receipt of this Lease Amendment. Registration must remain "Active" throughout the lease term and renewed annually. The Government will not process rent payments to Lessors without an active/updated SAM registration.**
