SUMMARY OF INFORMATION:

On November 8, 2019, the City/County Purchasing Department received bids for the purchase of two compact pickup trucks for use by the General Services Department as follows:

WHEREAS on October 29, 2019, the City/County Purchasing Department issued bid invitations for two compact pickup trucks to be used by the Forsyth County General Services Department to 15 local and regional qualified businesses;

WHEREAS bids were received and publicly opened by the City/County Purchasing Department at 12:00 PM on Friday, November 8, 2019, for the purchase of two compact pickup trucks per bid specifications at the request of the Forsyth County General Services Department and the following bids were received:

WHEREAS the lowest bid is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers discount prices to public agencies, compliant with N.C.G.S. 143-129(e)(3);

WHEREAS the County Manager, the County General Services Director, and the City/County Purchasing Director recommend that a contract for the purchase of two 2020 Ford Ranger pickup trucks per bid specifications in the amount of \$25,814.30 each be awarded to Capital Ford, Inc. for a total contract amount of \$51,628.60;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract for the purchase of two 2020 Ford Ranger pickup trucks per bid specifications is hereby awarded to Capital Ford, Inc., in the total amount of \$51,628.60 and that all other bids are hereby rejected, and that the County Manager and Clerk to the Board are hereby authorized to execute a contract with Capital Ford, Inc., for the purchase of such vehicles in a total amount of \$51,528.60, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
